When a puppy is adopted, we recommend running tests after a year has passed to establish whether the animal has one of the "Mediterranean diseases" eg Leishmaniasis. In case of adult dogs this will not be necessary because they will already have been tested. The test should be repeated after one year to be on the safe side.

§1

By signing the contract, you assume all rights and duties as far as the animal is concerned. You agree to cover all future animal related expenses.

§ 2

The charity makes no guarantees or warranties regarding the health, temperament, breed or age of the animal. The animal is being adopted as is.

You agree to be fully and solely responsible for this animal. The charity shall not be held liable for the behaviour of the animal or any damages it may cause thereafter.

§ 3

You agree to keep and take care of the adopted animal according to animal protection laws and regulations as well as other relevant laws and regulations (e.g. tax).

This implies, among others,

- Adequate shelter, dog / cat food and fresh water as well as outdoor exercise
- Refraining from any cruelty to the adopted animal
- Veterinary medical care whenever necessary and keeping vaccination current
- Not to use the adopted dog or cat for purposes contrary to this agreement (e.g. animal testing)
- Extensive house privileges and affection
- Taking appropriate measures to prevent the animal from running away

Furthermore, you agree

• To neuter the animal if this has not been done before the adoption

- Not to put down I the adopted animal in the event of behavioural problems but instead to contact us in order to check other options.
- To have the animal put down by a vet in case of incurable (and especially painful) conditions or diseases
- To inform us when you move to a different place and provide your new contact details

We suggest that you get a third party liability cover.

§4

The contract gives PLUTO protectora animales the right to reclaim the adopted animal without refund of the adoption fee or other compensation, if you do not/cannot any longer comply with the terms of this agreement.

§ 5

You may not rehome the adopted animal before we agree in writing. In case of unapproved rehoming, you would be liable to pay us 300 €.

§ 6

In the event of a culpable breach of the contract or if you provided incorrect information before the contract was signed, you would be liable to pay us 1000 €.

§ 7

You will pay an adoption fee of € when the animal is placed in her/his care.

§ 8

Animals in Spain are registered with **RIVIA**, a chip registration company in Valencia. If you live in another country, you will have to register the animal again according to national laws.

By signing this contract, you confirm that you have read and understood the contract and have received a copy. You accept the contract's content as fully binding.
