#### **§1** The caregiver agrees to

- Provide adequate food, water, shelter and humane treatment for said animal.
- Take all reasonable precautions to ensure that the animal cannot run away whilst in foster care.
- Ensure that the animal does not suffer any harm or causes harm to other people or animals.
- Inform PLUTO protectora animales immediately if the animal runs away and take suitable measures to find it.
- Refrain from handing over the animal to a third party for adoption or fostering.
- Pass the supervision of the animal to a third party (e.g. walking a dog) unless this person has sufficient experience of handling animals of this species.
- Inform us immediately in case of behavioural problems
- Ensure immediate veterinary care when required.
- Meet the individual needs of the animal.
- Make the animal part of the family and do not leave it, as far as possible, unattended.

# §2 The caregiver confirms to have sufficient

- Knowledge about how to treat dogs or cats.
- Time to take care of the animal and to meet the animal's individual needs.

# §3 Responsibilities of the owner

The owner will pay all veterinary bills. Please note that:

- General check-ups or routine medical tests have to be discussed beforehand with Angelika Macholl mobile: 0034 693 704 255.
- Emergencies should be reported as soon as possible.
- The costs of emergencies can only be reimbursed once the veterinary bill has been handed in.
- Follow-up treatments, administering medication, major laboratory tests or euthanasia recommended by a vet also have to be discussed beforehand.

Expenses will be reimbursed only when the above obligations are met

#### §4

PLUTO protectora animales has the right to end the fostering agreement at anytime if the association has found a suitable permanent home for the fostered animal. A formal cancellation is not required. It is sufficient merely to inform the caregiver.

We take the recommendations of the caregiver into account. However, the caregiver does not have the right to decide about who will finally adopt the animal and when this will happen.

#### §5

The association is not liable for any kind of damage caused by the fostered animal whilst in their care.

By signing this contract, you confirm that you have read and understood the contract and have received a copy. You accept the contract's content as fully binding.
